1. Institutional Purpose

Harvest Christian University Florida is a faith-based postsecondary religious institution established for the purpose of providing theological and ministerial education within a Christian worldview.

The institution exists to equip individuals for Christian ministry, leadership, and service through biblical, theological, and practical ministry training.

The mission of Harvest Christian University is to prepare students for service in churches, religious organizations, and faith-based ministries, emphasizing spiritual formation, biblical scholarship, ethical leadership, and ministerial competence.

2. Educational Programs and Curricula

Harvest Christian University Florida offers religious degree and non-degree programs exclusively in theological and ministerial disciplines. Programs include:

- Associate degree in Theology
- Bachelor's degree in theology
- Master's degree in theology
- Doctoral degree in Theology
- Certificate Programs in:
 - Christian Counseling
 - Christian Chaplaincy
 - Ministry-Related Fields

All programs are religious in nature and designed solely for ministerial preparation and Christian service.

Curricula include defined program objectives, course descriptions, instructional hours, assessment methods, and graduation requirements. Instruction emphasizes biblical studies, theology, ministry practice, and spiritual development.

3. Description of Physical Facilities

Harvest Christian University Florida utilizes the facilities of Linaje de Fe Church, located at:

- 3008 Partin Settlement Rd, Kissimmee, FL 34744
- 2885 Partin Settlement Rd, Kissimmee, FL 34744

These facilities provide adequate space for classrooms, student gatherings, and instructional activities consistent with institutional needs.

Courses are also offered through online instruction via Zoom, allowing students to participate remotely while maintaining access to faculty interaction, instructional materials, and learning resources.

4. Status Regarding Licensure (REQUIRED DISCLOSURE)

Harvest Christian University operates as a nonpublic religious postsecondary educational institution exempt from licensure pursuant to section 1005.06(1)(f), Florida Statutes.

The institution offers religious degree and certificate programs exclusively in theology and ministry and does not offer secular degree programs.

Harvest Christian University is not licensed by the Florida Commission for Independent Education and does not claim licensure, past or present.

5. Fee Schedule

Harvest Christian University Florida maintains a written and published fee schedule, which is provided to students prior to enrollment.

Typical fees include:

- Registration Fee: \$100
- Monthly Tuition: \$70
- Graduation Fee:
 - Undergraduate & master's Programs: \$200
 - Doctoral Programs: \$300

Gowns and mortarboards are not included.

The institution reserves the right to adjust fees with proper written notice.

6. Refund Policy (FULLY COMPLIANT – 6E-1.0032(6)(i), F.A.C.)

This refund policy applies to all students regardless of program or method of instruction.

a. Three-Day Cancellation Right

A student may cancel enrollment within three (3) working days after signing the enrollment agreement. All monies paid shall be refunded, except for the cost of any used or non-returnable supplies.

b. Cancellation Prior to Start of Instruction

Students who withdraw prior to the first day of instruction are entitled to a full refund of tuition, minus any non-refundable registration or administrative fee, not to exceed \$150.

c. Withdrawal After Instruction Has Begun

Refunds are prorated based on instructional time completed, subject to the following minimum standards:

- Programs charged in full: Refunds calculated up to 40% of the program
- Term-based tuition: Refunds calculated up to 20% of the academic term

d. Official Withdrawal

Refunds are processed only after receipt of written notice of withdrawal.

e. Refund Processing Timeframe

All refunds due are issued within thirty (30) days of official withdrawal or cancellation.

f. Federal Financial Aid

Harvest Christian University Florida does not participate in federal financial aid programs and does not administer Title IV funds.

7. Retention of Student Fees

Non-refundable fees, if applicable, are disclosed in writing prior to enrollment and are limited in accordance with Florida law.

8. Transferability of Credits

Credits earned at Harvest Christian University Florida are intended for use within the institution's own religious programs.

Transfer of credits to or from other institutions is not guaranteed and is determined solely by the receiving institution.

9. Student Assessment and Admission Criteria

Admissions decisions are based on evaluation of the applicant's ability to complete the program, which may include:

- Prior education and transcripts
- Ministry experience
- Personal statements
- Pastoral recommendations
- Interviews

10. Employment Placement Disclaimer

Harvest Christian University Florida does not provide job placement services and does not guarantee employment, salary, or career outcomes.

Any vocational guidance offered is informal and does not constitute placement services.

11. Relationship of Programs to State Licensure

All programs are religious and theological in nature.

Programs are not designed to meet licensure requirements for any secular or state-regulated profession in Florida.

Certificates in Christian Counseling and Chaplaincy are non-clinical and faith-based and do not qualify graduates for professional licensure.

12. Student Complaint Procedures

Students may submit written complaints to the administration. Complaints are reviewed by institutional leadership, documented, and resolved in writing within a reasonable timeframe.

13. Disciplinary Action Procedures

Violations of institutional policies or conduct inconsistent with Christian values may result in:

- Written warning
- Probation
- Suspension
- Dismissal

All actions are documented.

14. Appeal Procedures

Students may submit written appeals of academic or disciplinary decisions. Appeals are reviewed by institutional leadership, and a final written decision is issued.

15. Pre-Enrollment Disclosures

Prior to enrollment, students receive written disclosure of:

- Fees and costs
- Refund policy
- Graduation or exit requirements
- Minimum GPA requirement (2.0)
- Institutional religious status and accreditation disclosure, if applicable
